I. NOTICE OF AN APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

#### **NPDES PERMIT REISSUANCE**

### **Columbia County**

Dominion Energy South Carolina, Inc. – Stevens Creek Hydroelectric Station, 220 Operation Way, MC-C221, Cayce, South Carolina 29033, NPDES Permit No. GA0003786, for its hydroelectric power generating facility located at 406 Stevens Creek Road, Martinez, Georgia 30907 in Columbia County. A maximum of 0.27 MGD of top thrust bearing non-contact cooling water is discharged to the Savannah River in the Savannah River Basin.

#### **Douglas County**

Pine Lakes Mobile Home Park, LLC, 6310 East Kemper Road, Suite 125, Cincinnati, OH 45241, NPDES Permit No. GA0035271, for the Pine Lakes Mobile Home Park Water Pollution Control Plant located at 6266 Dorsett Shoals Road, Douglasville, Georgia 30135. Up to 0.05 MGD of treated wastewater is being discharged to Bear Creek in the Chattahoochee River Basin. The permit has also been modified to include language for an approved Sludge Management Plan to deliver sludge to another permitted facility for further treatment and ultimate disposal.

#### NPDES PERMIT MODIFICATION

#### **Bartow County**

City of Adairsville, 116 Public Square, Adairsville, GA 30103, NPDES Permit No. GA0046035, for the North Water Pollution Control Plant located at 179 Old Dixie Highway, Adairsville, Georgia 30103. The facility is authorized to discharge up to 1.0 MGD of treated domestic wastewater into Oothkalooga Creek in the Coosa River Basin. The permit is being modified to include effluent limitations and monitoring requirements for an expanded flow of 2.0 MGD. The City's Sludge Management Plan, incorporated under the referenced permit, to land apply sewage sludge is also being amended to include a new field (approximately 19 acres) on the Williams Property on Sam Sutton Rd NW in Bartow County.
