**I. NOTICE OF AN APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA**

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

**NPDES PERMIT NEW**

**Fulton County**

Thomas Concrete of Georgia, Inc., 2500 Cumberland Parkway, Suite 200, Atlanta, Georgia 30339, NPDES Permit No. GA0050285, for its ready-mixed concrete facility located at 695 Sims Industrial Blvd, Alpharetta, Georgia 30009 in Fulton County. A maximum of 0.12 MGD of concrete truck washout, batch plant process water, wash water, and dust suppression water commingled with stormwater is discharged to an unnamed tributary to Foe Killer Creek in the Chattahoochee River Basin.

**NPDES PERMIT REISSUANCE**

**Camden County**

The City of St. Marys, 418 Osborne St., St. Marys, Georgia 31558, NPDES Permit No. GA0037931, for the Scrubby Bluff Water Pollution Control Plant located at Haddock Road, St. Marys, Georgia 31558. Up to 0.5 MGD (monthly average) of treated wastewater is being discharged to Casey Creek in the St. Marys River Basin.

**Haralson County**

City of Buchanan, P.O. Box 6, Buchanan, Georgia 30113, NPDES Permit No. GA0021512, for the Buchanan Water Pollution Control Plant located at 1 Treatment Plant Road, Buchanan, Georgia 30113. Up to 0.17 MGD of treated wastewater is being discharged to Cochran Creek in the Tallapoosa River Basin. The permit also includes effluent limitations and monitoring requirements for the expanded flow of 0.40 MGD.

Up to 0.014 MGD of treated wastewater is being discharged to Unnamed Tributary to Picketts Mill Creek in the Coosa River Basin.

Chrysalis R.E., LLC, 4 Schindler Court, Boonton Township, New Jersey, 07005, NPDES Permit No. GA0023426, for the Whispering Pines Mobile Home Park Water Pollution Control Plant located at 1499 Bay Drive, Dalton, Georgia, 30721. Up to 0.038 MGD (monthly average) of treated wastewater is being discharged to Ketchum Creek in the Coosa River Basin.

In the case of the Industrial Pretreatment Program Approvals and Modifications comments are to be submitted to EPD no later than **January 13, 2019**.
