RE: Notification of Change to GA EPD's Public Notice Announcement Procedures

The Board of the Georgia Department of Natural Resources adopted amendments to our Chapter 391-3-6 rules to comply with the federal *NPDES: Applications and Program Updates* rule, 84 FR 3324 (eff. 6/12/19). Those amendments incorporate electronic public notice procedures into the rules, and in the near future, the Watershed Protection Branch will begin to utilize an e-mail subscription-based service through the GovDelivery delivery platform. Once the rule amendments have been approved by EPA, the Watershed Protection Branch will discontinue mailed notices regarding NPDES wastewater and stormwater permitting activities and will only use the GovDelivery system.

If you would like to subscribe for email notifications regarding NPDES wastewater and stormwater permitting activities, please send an email to Ms. Nicki Dorsey at andronicki.dorsey@dnr.ga.gov. In that email, please indicate the mailing address to which you currently receive these notices, and whether you will be accepting email notifications on behalf of a particular organization. Once your request is received, Ms. Dorsey will add your email address to a new email subscriber list for the Watershed Protection Branch's "Permit-related Notices" subscription topic and will discontinue to send you mailed notices via U.S. Postal Service.

The Watershed Protection Branch intends to begin utilizing this new email subscription topic in the near future. Those subscribed will begin to receive emails whenever a permit-related notices is posted to the Branch's announcements website (<https://epd.georgia.gov/watershed-protection-branch-public-announcements>). In addition to NPDES wastewater and stormwater permitting activities, this topic will provide email notification to subscribers regarding permit-related public notices posted to the website related to land application systems, water withdrawals, pretreatment, State Environmental Review Process reviews of GEFA-funded projects, and permit-related public meetings or hearings.

The Environmental Protection Division (EPD) has reviewed applications is considering the issuance, modification, or termination of National Pollutant Discharge Elimination System (NPDES), Land Application System (LAS), and/or Pretreatment permits, Sludge Management Plans, and/or Industrial Pretreatment Programs to the following applicants, subject to specific pollutant limitations and special conditions.

NPDES, LAS, and Pretreatment permits are valid for a maximum of five years. A new application must be submitted 180 days prior to the expiration date of the existing permit, evaluated by EPD, and the draft permit be placed on public noticed for a prescribed period of time.

For proposed new or expanded NPDES point source discharge permits, an antidegradation analysis is conducted. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing designated use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy (SDS) in order to receive a permit.

EPD issues permits in compliance with the governing regulations and is not involved in local zoning, land use, or property value issues. The issuance or modification of a permit, plan or program does not authorize the facility to violate local ordinances. Please contact your local county or municipal officials for questions or concerns on these issues.

Persons wishing to comment upon or object to the proposed permit determinations are invited to submit same in writing to the EPD address below or via e-mail at EPDcomments@dnr.ga.gov, no later than **August 14, 2020** (30-day notice period). In the case of Industrial Pretreatment Program Approvals and Modifications, comments are to be submitted to EPD no later than **August 31, 2020** (45-day notice period). Please use the words “**Public Notice No. 2020-13ML**” and the name of the subject facility that you are commenting on in the subject line to ensure that your comments will be forwarded to the correct staff. All comments received prior to or on that date will be considered in the formulation of final determinations regarding the application. In the case of the permits which are on this notice for proposed modification, only those conditions subject to modification are open to public comment. A public hearing may be requested or additional information regarding public hearing procedures is available by writing to the EPD at 2 MLK Jr. Dr. S.W., 1152 East Tower, Atlanta, Georgia 30334.


