**NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS
TO GEORGIA'S RULES FOR RADIOACTIVE MATERIALS
SUBJECT 391-3-17**

TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes Amendments to Georgia's Rules for Radioactive Materials, Subject 391-3-17 (hereinafter, "the proposed Radioactive Materials Rule Amendments"). The Director of EPD certifies that the revisions to Subject 391-3-17 are required to comply with and implement section 274 of the Atomic Energy Act. The proposed Radioactive Materials Rule Amendments are described below:

Rule 391-3-17-.01(2), "Definitions," is being amended to ensure the consistency of the rules with the requirements of the Nuclear Regulatory Commission (NRC), to correct a typographical error, and to update nomenclature.

Rule 391-3-17-.03(12), "Precautionary Procedures," is being amended to ensure the consistency of the rules with the requirements of the NRC.

Rule 391-3-17-.03(15), "Reports," is being amended to ensure the consistency of the rules with the requirements of the NRC.

Rule 391-3-17-.04(19), "Personnel Monitoring Control," is being amended to ensure the consistency of the rules with the requirements of the NRC.

Rule 391-3-17-.05(2), "Definitions," is being amended to ensure the consistency of the rules with the requirements of the NRC and to correct a typographical error.

Rule 391-3-17-.05(22), "Training for Radiation Safety Officer," is being amended to ensure the consistency of the rules with the requirements of the NRC.

Rule 391-3-17-.05(25), "Training and Technical Requirements for Nuclear Medicine Technologists and Radiation Therapists," is being amended to ensure the consistency of the rules with the requirements of the NRC.

Rule 391-3-17-.05(26), “Provisions for Experienced Radiation Safety Officer, Teletherapy or Medical Physicist, Authorized Medical Physicist, Authorized User, Nuclear Pharmacist, and Authorized Nuclear Pharmacist,” is being amended to ensure the consistency of the rules with the requirements of the NRC and to update nomenclature.

Rule 391-3-17-.10, “Administration,” is being amended to further define and establish more detail in fee categories and to update nomenclature.

Rule 391-3-17-.13, “Physical Protection of Category 1 and Category 2 Quantities of Radioactive Materials,” is being amended to ensure the consistency of the rules with the requirements of the NRC and to update nomenclature.

This notice, together with an exact copy of the proposed Radioactive Materials Rule Amendments, a synopsis, and a statement of rationale of the rule revisions, is being provided to all persons who have requested in writing that they be placed on a notification list.
