This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}:   A  

Description and Location of Proposed Activity:

Applicant proposes to impact a total of 65 linear feet (1,132 ft<sup>2</sup>) of stream buffer along the Etowah River to construct a boat launch for canoes and kayaks for public recreational use. The boat launch will be 16'-wide and constructed of scored concrete with an adjoining 6'-wide concrete sidewalk with steps and handrail. The project is located at the Hardin Bridge on Hardin Bridge Road.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
