The applicant proposes to impact 295 linear feet (12,084 ft²) of stream and buffer with pipe and fill along an unnamed tributary to Rosemary Branch to extend an airport runway and improve the airfield at the Burke Co. Airport (BXG). The runway will be extended by 1,180 feet. Impacts are unavoidable and do not allow additional airport extension to the east due to GA Hwy. 121. Project is located at 475 Airport Rd.
