The proposed project involves buffer encroachments necessary to construct a warehouse and associated infrastructure off of Campbell Boulevard and 3rd Street in Forest Park. The project will impact 58 acres including permanent impacts (pipe/fill) to 424 total linear feet (23,891 total square feet) of buffer along two tributaries to Upton Creek in the Upper Ocmulgee Watershed (03070103).
