This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Site plans are available for review and are located in the following EPD office: Watershed Protection Branch, 200 Piedmont Avenue SW, Suite 418 West, Atlanta, GA 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.11 (2)(a-k)}: (a) and (d)

Description and Location of Proposed Activity:

This project will consist of replacing an *existing* aerial sewer line crossing and installing *new* concrete support piers and relocating an *existing* sewer line segment currently located along the streambank (exposed and susceptible to failure caused by significant erosion of the streambanks). The proposed streambank stabilization will consist of grading the eroding streambanks to a more stable slope and soil bioengineering practices (including like staking with coconut fiber rolls and joint planting/vegetative riprap and/or Filtrexx[®] streambank stabilization system with live stake cuttings). The proposed project will result 132 linear feet total (1,098 square feet total) of buffer impacts along Mt. Enna Branch near Wellington Drive in the *Middle Savannah Watershed* in Columbia County.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
