The proposed project involves buffer encroachments necessary to construct a warehouse facility and associated infrastructure south of U.S. HWY 29, west of Clarence McCambry Road and I-85 in Coweta County. The project will require 65 acres of disturbance on 85.09 acres, including permanent impacts (pipe/fill) to 1,037 total linear feet (60,585 total square feet) of buffer along two unnamed tributaries to Yellowjacket Creek in the Middle Chattahoochee Watershed (03130002).
