Description and Location of Proposed Activity:

The applicant proposes to impact a total of 1,245 linear feet (24,942 square feet) to four open waters within the Flint River watershed for a bridge replacement. Disturbance activities will consist of clearing, placement of fill, construction access, installation of guardrail, orange barrier fence and BMPs within the buffer. This project is located on State Route 253/Spring Creek Road over Spring Creek in Decatur County.
