Lake Charles Plantation Clubhouse Complex-Retaining Wall Replacement  
Activity

This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A

Description and Location of Proposed Activity:

The applicant proposes to impact a total of 182 linear feet (2,267 ft<sup>2</sup>) of stream buffer along a tributary to Pine Grove Branch to replace the failing existing wood timber retaining wall with a segmental retaining wall. The segmental wall will be constructed within the same alignment as the existing wall's footprint. Upon completion of land disturbing activities, the stream buffer will be stabilized with native riparian vegetation and restored to pre-existing conditions as much as is practicable. The project is located at the Lake Charles Plantation Clubhouse complex off Plantation Drive.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
