This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: ___A

Description and Location of Proposed Activity:

Applicant proposes to impact a total of 195 linear feet (6,514 ft²) of stream buffer along an unnamed tributary to the Chattahoochee River to install a permanent maintenance access for proposed and future dredging activity of Lake Northridge. The entrance will be located near 1220 Tynecastle Way NE on the east side of the stream. The instream and buffer encroachment feature will be approximately 33'x34' (472 ft²) and will have 3-48" reinforced concrete pipe with a 12" top layer of ASTM 57 stone. One 6,042 ft² section of established sediment within the buffer that has resulted from a breached earthen berm will be excavated in order to re-establish the original contours of the stream buffer. Timber matting will be used to cross buffers and access the lake during dredging activity, which will be done with long-reach excavators. The dredged sediment will be placed in the on-site disposal area outside the 25-foot buffer. The project site is located off Tynecastle Way in Sandy Springs.
