Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: F

Description and Location of Proposed Activity:

The applicant proposes to impact 334 linear feet (3,267 ft<sup>2</sup>) of stream buffer along an unnamed tributary to the Chattahoochee River to construct a multi-use recreational trail and conduct sidewalk improvements. Impacts to the stream buffer include construction of an elevated boardwalk and construction of a guardrail and best-management practices. The multi-use trail will connect the existing trail systems along Bell Rd. and Rogers Trail Circle that ends just south of Nellie Brook Court.
