Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to construct a roundabout at the intersection of Hopewell Road and Hamby Road in the City of Milton. Disturbance activities will consist of placement of fill, grading, and installation of BMPs. The project will result in a total of 290 linear feet (3323 square feet) of buffer impacts to an unnamed tributary to Chicken Creek within the *Etowah River Watershed*.
