Description and Location of Proposed Activity:

This project will consist of constructing a porous concrete trail extension and raised overlook platforms around Morrison Lake with engineered concrete foundations and bioengineered stormwater controls. All areas with disturbed or exposed soils within the project limits will be replanted with a multi-trophic native riparian vegetation and grasses. The proposed project will result in 1,833 linear feet (30,712.4 square feet) of buffer disturbance off Lakeview Parkway, located on an unnamed tributary of Big Creek in the Upper Chattahoochee Watershed (03130001).
