This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The proposed project will consist of constructing a new mixed-use development and associated infrastructure on approximately 64 acres in the southeast quadrant of the Buford Drive and Interstate 85 interchange in Gwinnett County. This project will include an on-site stormwater management system (including dry extended detention basins, underground detention, porous asphalt (with underdrain) and *FleXstorm Pure* inlet filters). Construction activities will result in 1,584 linear feet total (79,175 square feet total) of buffer disturbances along four unnamed intermittent streams, tributaries to Ivy Creek in the *Upper Chattahoochee Watershed*.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
