Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to construct football stadium and associated infrastructure at the intersection of Buford Highway and Robert Bell Parkway off New Street in the city of Buford. The project will require 33.25 acres of disturbance including permanent impacts (pipe/fill) to 2,252 total linear feet (141,253 total square feet) of buffer along two dendritic tributaries to Suwanee Creek in the Upper Chattahoochee Watershed (03130001).
