Description and Location of Proposed Activity:

This project involves buffer encroachments necessary to construct a distribution center and associated infrastructure off Roy Carlson Boulevard in Gwinnett County. The project will require 86.1 acres of disturbance including permanent impacts (pipe/fill) to 3,136 total linear feet (191,726.47 total square feet) of buffer along an three unnamed dendritic tributaries to Suwanee Creek in the Upper Chattahoochee Watershed (03130001).
