This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Site Plans are immediately available for review and are located in the following EPD office: Watershed Protection Branch 200 Piedmont Avenue, S.W. Suite 418 West Atlanta, Georgia 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2) (a-k)}: (a) and (h)

Description and Location of Proposed Activity:

Application proposes to impact buffers to Perennial Stream 5 and Intermittent Stream 5B (tributaries of Chattahoochee River) and Open Water 10 (Lake Lanier) within Upper Chattahoochee River watershed for the replacement of a structurally deficient bridge over the Chattahoochee River at its confluence with Lake Lanier. Disturbance activities will consist of clearing, access for installation of temporary work piers, placement of fill, new road embankment, installation of orange barrier fence and type C silt fence, installation of stormwater drainage outfall and placement of rip rap within the buffer. The project on State Route 11/Hwy 129 located approximately 3 miles northeast of Gainesville in Hall County.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
