Description and Location of Proposed Activity: The proposed project would impact Open Water (OW) 3, OW 6, OW 28, and OW 37 for the widening of State Route (SR) 31/US Highway 441 (US 441). The project would impact 6302 square feet/ 464 linear feet of the 25-foot state mandated buffer within the Lower Oconee watershed. Disturbance activities will consist of grading activities to achieve proper roadside slope and drainage, and space to allow for the installation of erosion and sedimentation control best management practices and orange barrier fence.
