Description and Location of Proposed Activity: The proposed project would impact Open Water (OW) 2A for the interchange improvement of I-75 at Bellville/Lake Park Road. The project would impact 588.15 square feet/80 linear feet of the 25-foot state mandated buffer within the Withlacoochee watershed. Disturbance activities will consist of vegetative clearing and trenching for utility line relocations of water and sewer lines, and installation of type C silt fence and orange barrier fence.
