City of Greenville-Sewerage System Improvements

This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A & D

Description and Location of Proposed Activity:

Applicant proposes to impact a total of 50 linear feet (545 ft<sup>2</sup>) of stream buffer along a tributary to Walnut Creek to provide improvements to the existing sewer system. The existing pump station, gravity sewer line, and force main currently within the stream buffer will be abandoned. A new 10" gravity sewer line will slightly impact the buffer while the proposed pump station will be constructed outside the 25-foot stream buffer. The project site is located adjacent to Pear St. along a private gravel drive.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
