Description and Location of Proposed Activity:

The applicant proposes to permanently impact 833 linear feet (45,950 ft²) of stream and buffer along an unnamed tributary that flows into Fourmile Branch with pipe and fill to construct a second phase of an HVAC manufacturing facility on a 29-acre site. An additional 86 linear feet (4,300 ft²) of stream at the north end will be re-aligned with the proposed pipe, dredged to remove accumulated sediment, and the streambanks re-vegetated. Project includes a 300,000 ft² manufacturing building and installation of associated infrastructure. The project is located on GA83 at 1310 Monticello Rd.
