Description and Location of Proposed Activity:

The Chatsworth Water Works Commission proposes to build the Mill Creek Water Pollution Control Plant (WPCP). The proposed installation of the WPCP outfall will impact the state-mandated buffer. Construction activities within the buffer include clearing, installation of outfall pipe, headwall, riprap and BMPs. The proposed project will impact a total of 94 linear feet (1,247 square feet) of buffer along Mill Creek in the *Conasauga River* Watershed.
