Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered $\{391-3-7-.05(2)(a-k)\}$: (a)

Description and Location of Proposed Activity:

The Forest Hills Golf Course Dam is located on an unnamed tributary to Rae's Creek along Lake Forest Drive in Augusta. To ensure compliance with the *Georgia Safe Dams Act*, this project will consist of raising the top of the dam and installing a wave wall, installing new toe drains and an articulated concrete block emergency spillway, replacing the existing siphon system and outlet structure and installing a new riprap apron and an energy dissipating basin. All disturbed areas will be restored to current conditions to the extent practicable. The proposed project will result in approximately 900 linear feet total (44,600 square feet total) of buffer disturbances along the Forest Hills Golf Course Dam and an unnamed stream, a tributary to Rae's Creek, in the *Middle Savannah Watershed*.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
