Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Basis under which variance shall be considered $\{391-3-7-.05(2)(a-k)\}$: (d)

Description and Location of Proposed Activity:

The proposed project will make sewerage system improvements to existing undersized sewer lines. Disturbance of the buffer is necessary in order to replace the gravity sewer lines that are located within the vegetative buffer boundaries. A Buffer Mitigation Plan, Revegetation Plan, and erosion control measures are implemented to address major impacts. The proposed project will result in 995 total linear feet (19,537 total square feet) of buffer disturbance lasting approximately 30 days. The project is located on Yellowjacket Creek (Hogansville to West Point Lake segment) of the Upper Middle Chattahoochee Watershed (03130002).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
