Description and Location of Proposed Activity: The proposed project would impact Wetlands 08, 09 and 10 (salt marshes adjacent to Sterling Creek) for the widening of State Route (SR) 144 from south of County Road (CR) 100 to south of CR 154. Additional through lanes and turn lanes are proposed along the existing two-lane road, in order to improve safety and operational conditions on SR 144. The project would impact the 25-foot state mandated buffer under criterion 2(a) within the Ogeechee Coastal watershed.
