Description and Location of Proposed Activity:

The proposed infrastructure project will consist of constructing a *new* public use, one-way road (15-foot wide) to access residential lots along an existing right-of-way between Solomon Avenue and Alger Avenue on Tybee Island. The proposed project will result in approximately 90 linear feet total (2,265 square feet total) of buffer disturbances along coastal marshlands adjacent to Chimney Creek in the *Ogeechee Coastal Watershed*.
