Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7-.11 (2)(a-k)}: (f)

Description and Location of Proposed Activity:

The project will install a pervious walking trail. Buffer intrusions are related to adding permanent pervious fill for walking trail construction and will be mitigated with native riparian vegetation where practicable. The proposed project will result in approximately 3,518 linear feet (23,522.4 square feet) of buffer disturbance. The site is located along Dutch Island Causeway adjacent to Herb River. This project located in the Ogeechee Coastal Watershed.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
