Description and Location of Proposed Activity:

This project consists of the installation of 160 feet of bulkhead placed landward of Coastal Marsh Protection Act jurisdiction to protect residential dwelling from bank erosion and encroaching tide levels. The area will be filled at grade to match existing lawn. No additional impervious surfaces will be constructed within 25 ft of proposed bulkhead. The proposed project will result in 160 total linear feet (3,861.96 total square feet) of coastal marsh buffer disturbance. This project located off Old Seaside Drive in the Cumberland-St. Simmons Watershed (03070203).
