Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (b,f)

Description and Location of Proposed Activity:

This project will result in the construction and repair of existing infrastructure currently located within the buffer to include buffer mitigation in areas currently being impacted by the public. The project elements in the buffer include concrete trail, infiltration bands and infrastructure to prevent streambank erosion, treat stormwater runoff, and promote more stable public access. The proposed project will stabilize 1,089 total linear feet streambank resulting in 15,649 total square feet of buffer disturbance along Little Amicalola Creek in the Etowah Watershed (03150104).
