Description and Location of Proposed Activity:

This project will construct stringer stairs to the river's edge to launch, kayaks, canoes, and floats. Acceptable streambank stabilization methods will include joint planting with live stakes, fiber mating, and riprap to dissipate energy and protect the banks from further streambank erosion along the Tallapoosa River. The proposed project will result in approximately 20 linear feet total (400 square feet) of buffer impact along the Tallapoosa River in the Upper Tallapoosa Watershed (03150108).
