This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.11 (2)(a-k)}: (b)

Description and Location of Proposed Activity:

The proposed mitigation for the *Helen to Hardman Farm State Historical Site – Heritage Trail* will consist of removing invasive vegetation (e.g., privet) and planting multi-trophic native riparian vegetation along an unnamed perennial stream located along the Unicoi Turnpike in Sautee Nacoochee. The proposed streambank restoration will result in 1,000 linear feet (50,000 square feet) of buffer impacts along an unnamed perennial stream, a tributary to the Chattahoochee River in the *Upper Chattahoochee Watershed* in White County.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
