Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a) and (f)

Description and Location of Proposed Activity:

The applicant proposes to impact a total of 119 linear feet (2,195 square feet) of stream buffer along the Chattahoochee River to construction a raised boardwalk, viewing platform and install a bioretention stormwater outfall. The improvements are for updating the boardwalk and expanding the "view shed" for educational purposes associated with the Nature Center and will improve streambank integrity. The project is along the Chattahoochee River in the Upper Chattahoochee Watershed (03130001).
