Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed buffer variance impact consists of constructing a canoe launch and stabilizing the streambank with riprap and acceptable streambank stabilization methods, including joint planting with live stakes, to dissipate energy and protect the banks from further streambank erosion inside Henry-Horseshoe Bend Park. The proposed project will result in approximately 100 linear feet total (1,000 square feet) of buffer impact lasting approximately 3 months. The project is along the Toccoa River in the Ocoee Watershed (06020003).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
