This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: a

Description and Location of Proposed Activity: The proposed project would impact Intermittent Stream (IS) 1 (unnamed tributary to Mud Creek) and Perennial Stream (PS) 3 (Mud Creek) buffers. The proposed project will consist of intersection spot improvements focusing on five critical areas along the project corridor. The proposed project would impact 1,933 square feet/ 76 linear feet of the 50-foot state mandated buffer within the Coosawattee River Watershed (HUC 03150102). Disturbance activities will consist of placement of fill and rip rap, clearing for construction access, and placement of silt fence for erosion, sediment, and pollution control measures [best management practices (BMPs)] along with orange barrier fence (OBF).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
