Description and Location of Proposed Activity:

The proposed project will impact the buffer of Open Water 23, Perennial Stream (PS) 24, Intermittent Stream (IS) 24b, PS 24d, PS 25b, and PS 26. The project will widen and reconstruct the US 441/SR 15 corridor in Rabun County. The project will impact the state mandated 50-ft buffer within the Upper Little Tennessee River Watershed (HUC 0601020201). The disturbance will cover 24,275 square feet and include cut and fill for roadway embankment, discharge of fill due to placement of riprap along roadside ditches, permanent fill to construct a driveway, discharge of fill associated with the construction of a drainage pipe with level spreader, clearing and grubbing for construction access, and the installation of Best Management Practices (BMPs).
