Description and Location of Proposed Activity: <u>The proposed project will impact the buffer of Intermittent Stream</u> (IS) 30, Perennial Stream (PS) 30A, PS 33, IS 34, IS 35, PS 37A, IS 39, IS 40B, PS 42, IS 44, PS 45 (Caldwell Branch), IS 48A, IS 50, PS 51, PS 52, IS 52C, Buffered State Water (BSW) X, PS 53, PS 54, IS 55, PS 61, and PS 66. The project will improve SR 515/US 76 from Young Harris Street in the city of Blairsville in Union County to Timberline Drive in the city of Young Harris in Towns County. The project will impact the state mandated 50-ft buffer within the Hiwassee River watershed (HUC 06020002). The disturbance will cover 87,949 square feet and include construction access, roadway cut/fill, riprap, pavement demolition, wall construction, and the installation of Best Management Practices (BMPs).
