Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the construction of a boathouse and porch along the shoreline of Lake Laceola, an impoundment on Blue Creek in White County. Land disturbing activities to construct the 688 square foot boathouse and porch will result in a total of 51 linear feet (4,304 square feet total) of buffer disturbance, which will account for construction, BMPs, and revegetation. The project is located along Lake Laceola off Mountain Streams Drive in the Upper Chattahoochee Watershed (03130001) and will provide access to Lake Laceola. The shoreline buffer will be replanted with native riparian plant species upon completion of the three-month project.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
