On August 11, 2014, EPD listed the upgradient property, One Hour Martinizing (Former) property, on EPD's Hazardous Site Inventory (HSI #10922) and sublisted the Bellemeade Shopping Center property as part of that site. Therefore, EPD will eventually require the responsible party(ies) to investigate the site. Boyd Georgia Property, LLC as the owner of the sublisted Bellemeade Shopping Center property is obligated to allow access to the property for the possible installation of monitoring wells and/or a remediation system.

Due to the sublisting of the Bellemeade Shopping Center property and downgradient location relative to the listed site, Boyd Georgia Property, LLC may choose to withdraw from enrollment in the Voluntary Remediation Program (VRP). If so, please send EPD a written response that effect. If not, then EPD expects that Boyd Georgia Property, LLC will continue to comply with the requirements of the VRP including the submission of semi-annual reports.
