## PUBLIC NOTICE NOTICE OF PART B PERMIT APPLICATION

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, under requirements set forth in Title 40, Section 124.32 of the Code of Federal Regulations, announces the submittal of a Resource Conservation and Recovery Act (RCRA) Part B Permit Application for renewal of Hazardous Waste Facility Permit No. 034(D), issued to U.S. Air Force Plant 6 (hereinafter, "Air Force Plant 6") on November 14<sup>th</sup>, 2009. The RCRA Part B Permit Application was submitted in accordance with the provisions of Subtitle C of RCRA.

Air Force Plant 6 is a government-owned facility operated by Lockheed Martin Aeronautics Company, used for the production and modification of various military aircrafts. The facility is located on approximately 750 acres in Cobb County, Georgia, which is adjacent to the cities of Marietta and Smyrna, and approximately 15 miles northwest of Atlanta. The facility's identification number is GA8570024606. The RCRA Part B Application was submitted to EPD on April 11, 2019, with a final revised version submitted November 3, 2020. The Part B Permit Application was prepared by Air Force Plant 6 for the purpose of outlining activities related to the corrective action of contaminated groundwater and investigation and subsequent corrective action (if warranted) of solid waste management units at the facility. Before renewing the permit, state and federal regulations require that EPD provide an opportunity for public comment on the RCRA Part B Permit Application. Accordingly, a public comment period has been arranged for May 12, 2021 through June 10, 2021.
