

PUBLIC NOTICE  
Notice of Intent to Renew Permit

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, under the authority of the Georgia Hazardous Waste Management Act, O.C.G.A. 12-8-60, *et seq.*, as amended, announces its intent to renew Hazardous Waste Facility Permit HW-062(D) issued to William C. Meredith Company for post-closure care and corrective action of a closed hazardous waste landfill. The facility is located at 2335 Lawrence Street, East Point, Georgia 30344, identified by the assigned facility EPA I.D. No. GAD003323805.

The draft permit requires William C. Meredith Company to perform corrective action and to conduct post-closure care at the facility. NO ADDITIONAL DISPOSAL OF HAZARDOUS WASTES AT THE FACILITY WILL BE ALLOWED UNDER THIS PERMIT RENEWAL.

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, upon issuance, the permit will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA.

The draft permit has been prepared in accordance with the Georgia Rules for Hazardous Waste Management (Rules), Chapter 391-3-11. Before making a final decision to renew the permit, Section 391-3-11-.01 (40 CFR 124.10) of the Rules requires EPD to provide an opportunity for public comment. Accordingly, a public comment period has been established from June 4, 2025, to July 22, 2025.
