NOTICE OF INTENT TO RENEW PERMIT

The Environmental Protection Division (EPD) of the Department of Natural Resources, under the authority of the Georgia Hazardous Waste Management Act, O.C.G.A. Section 12-8-60, et seq., as amended, announces its intent to renew Hazardous Waste Facility Permit Number HW-047(D) issued to Manor Timber Company for the post closure care of a hazardous waste landfill. The landfill is owned by and located at Manor Timber Company, 102 Black Ankle Road, Argyle, Georgia 31623, having the assigned Facility Identification Number GAD061921052.

On September 30, 1997, EPD issued Hazardous Waste Facility Permit Number HW-047(D) to Manor Timber Company for post closure care and corrective action for a hazardous waste surface impoundment closed as a landfill. This permit addresses post closure care for the landfill, corrective action for groundwater contamination, and corrective action for solid waste management units identified on site. The draft permit, which is the subject of this notice, proposes to renew the existing permit to assure that Manor Timber Company continues to comply with the currently applicable requirements in 40 CFR Parts 124, 260 through 266, 268 and 270.

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, the permit, as renewed, will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA. **This permit does not authorize the disposal of additional hazardous waste at Manor Timber Company.**

The draft permit has been prepared in accordance with Georgia Rules for Hazardous Waste Management, Chapter 391-3-11. Before making its final decision to renew the permit, Section 391-3-11-.11(4)(a) of the Rules requires EPD to provide an opportunity for public comment. Accordingly, a public comment period has been arranged from **August 2, 2023, to September 20, 2023**. During the public comment period, a copy of the draft permit and supporting documents will be made available for public review at the following locations during regular business hours:
