PUBLIC NOTICE NOTICE OF INTENT TO MODIFY PERMIT

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, under the authority of the Georgia Hazardous Waste Management Act, O.C.G.A. Section 12-8-60, <u>et. seq.</u>, as amended, announces its intent to modify Hazardous Waste Facility Permit No. HW-041(CA) issued to the University of Georgia (UGA) located in Athens, Georgia. This permit was issued on December 17, 2019 for investigation and corrective action to remediate releases of hazardous constituents into the environment. If modified, the permit will incorporate the final corrective action plan into the permit. The proposed corrective action consists of in-situ chemical oxidation, high vacuum vapor and groundwater extraction, and monitoring.

EPD initially issued Hazardous Waste Facility Permit No. HW-041(S&T) to UGA on June 12, 1987 for the storage of 5,500 gallons of hazardous waste in containers and for the treatment of 1,000 gallons per year of heavy metal aqueous solutions. UGA certified clean closure for the heavy metal evaporation unit in 2007. In 2018, UGA certified clean closure for the remaining hazardous waste storage areas. However, between 1969 and 1979 UGA operated a solid waste landfill, the Milledge Avenue Landfill ("Landfill") located in Athens, Clarke County Georgia. The Landfill was a disposal site for laboratory waste from UGA and Permit HW-041(CA) was issued to address discovered releases of hazardous constituents to the environment. The modified permit, if approved, will require UGA to implement the May 2022 100% Remedial Design for Corrective Action at the Landfill.

A draft modified permit has been prepared in accordance with the provisions of the Georgia Rules for Hazardous Waste Management, Chapter 391-3-11, which contains the conditions for the investigation and corrective action of known and any discovered releases of hazardous constituents into the environment from previous operations at the facility. The draft permit does not allow for disposal of hazardous waste on-site.

Before making its final decision on whether to issue the modified permit, state and federal regulations require that the EPD provide an opportunity for public comment. Accordingly, a public comment period has been arranged for March 23, 2023 through May 6, 2023. The applicant and those persons who submit written comments or request notice of the final permit decision will be notified of the final permit determination made by the Director of EPD. EPD will announce any substantial changes in the final determination by public notice.
