## PUBLIC NOTICE Notice of Intent to Modify to Terminate Permit

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, under the authority of the Georgia Hazardous Waste Management Act, O.C.G.A. 12-8-60, <u>et seq.</u>, as amended, announces its intent to modify Hazardous Waste Facility Permit HW-092(D) issued to Matthews International Corporation (d.b.a. The York Group, Inc. / York Casket Hardware) for corrective action. Following the effective date of the permit modification, the permit will terminate subject to an executed Consent Order. The facility is located at 506 Maltbie St, Lawrenceville, Georgia 30046, identified by the assigned facility EPA I.D. No. GAD003265030.

The draft modified permit requires Matthews International Corporation (d.b.a. The York Group, Inc. / York Casket Hardware) to perform corrective action at the facility. NO ADDITIONAL DISPOSAL OF HAZARDOUS WASTES AT THE FACILITY WILL BE ALLOWED UNDER THIS MODIFIED PERMIT.

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, upon issuance, the modified permit will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA.

The draft modified permit has been prepared in accordance with the Georgia Rules for Hazardous Waste Management (Rules), Chapter 391-3-11. Before making a final decision to modify the permit, Section 391-3-11-.01 (40 CFR 124.10) of the Rules requires EPD to provide an opportunity for public comment. Accordingly, a public comment period has been established from November 26, 2025, to January 13, 2026.
