# I. NOTICE OF APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted as applicable for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

### **DOUGLAS COUNTY**

Douglasville–Douglas County Water and Sewer Authority (WSA), Post Office Box 1157, Douglasville, Georgia, 30133, NPDES Permit No. GA0047201, for the Sweetwater Creek water pollution control plant located at 1565 Roberts Road in Douglasville. Up to 3.0 MGD of treated wastewater is discharged to the Chattahoochee River in the Chattahoochee River Basin. The permit also contains provisions for an expansion to 6.0 MGD as in the current permit.

Georgia Renewal Power, Plant Carl, 3465 Highway 198, Carnesville, Georgia 30521, NPDES Permit No. GA0039292, for its biomass renewal energy power plant located in Carnesville. Approximately 0.6 MGD of cooling water, boiler blowdown, and other utility water is discharged to an unnamed tributary of Indian Creek in the Savannah River Basin.

Approximately 0.60 MGD of cooling water is discharged to the Tallulah River in the Savannah River Basin.

Georgia Power – Tugalo Hydroelectric Plant, 241 Ralph McGill Boulevard, NE, Bin 10221, Atlanta, Georgia 30308-3374, NPDES Permit No. GA0004189, for its Hydroelectric Plant located in Tallulah Falls. Approximately 1.30 MGD of cooling water is discharged to the Tugalo River in the Savannah River Basin.

### **JEFF DAVIS COUNTY**

Beasley Forest Products, Inc., P.O. Box 788, Hazlehurst, Georgia 31539, NPDES Permit No. GA0038628, for its facility on 712 Uvalda Hwy, in Jeff Davis County. The existing discharge of wet deck log storage overflow water enters Mill Branch in the Ocmulgee River Basin.

## REVOCATION OF THE GENERAL PERMIT FOR THE LAND APPLICATION (LAS) OF ANIMAL FEEDING OPERATIONS (AFOS)

Georgia Land Application System Permit No. GAU700000

Pursuant to the Georgia Rules and Regulations for Water Quality Control, Chapter 391-3-6, EPD is proposing to revoke the general permit for land application system of animal feeding operations, AFOs, issued on June 13, 2002, that covered owners of existing and new AFOs, including swine feeding operations, with more than 300 but equal to or less than 1000 animal units (AU).

On April 1, 2014, EPD issued two new LAS general permits for AFOs based on the size of the operation. General Permit No. GAG920000 was issued to owners of existing, new, and expanding animal feeding operations (301 to 1000 animal units category) that are required to have a land application system permit. General Permit No. GAG940000 was issued to owners of existing, new, and expanding animal feeding operations (more than 1000 animal units category) that are required to have a land application system permit.
