Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This project will consist of installing \pm 485 linear feet of 4" Ø ductile iron pipe (raw water line) and constructing a new well house and treatment building and a 12-ft wide gravel access road (\pm 485 linear feet) from Evans Street to the new well house and treatment building in Homer. The proposed project will result 63 linear feet total (850 square feet total) of buffer impacts along an unnamed perennial stream, a tributary to the Hudson River, in the Broad Watershed. The disturbed areas along the unnamed perennial stream will be stabilized with permanent vegetation and restored to current conditions to the extent practicable.
