This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05(2)(a-k)}: (a)

Description and Location of Proposed Activity: **The proposed project would impact buffers to two Intermittent Streams (IS), and two Perennial Streams (PS) for the new construction and widening of Tom Miller Road. The project would impact the 25-foot state mandated buffer of unnamed tributaries to Williamson and Cedar Creeks within the Upper Oconee watershed. Disturbance activities would consist of culvert extension, grading of the roadway embankment, installation of roadway drainage structure, construction encroachment, and installation of orange barrier fence The proposed project begins just south of the intersection of Tom Miller Road and State Route (SR) 316, and aligns with Barrow Park Drive, and ends connecting with SR 211 just north of Barrow Park Drive.**

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
