Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05(2)(a-k)}: (h)

Description and Location of Proposed Activity: The proposed project would impact buffers to one Intermittent Stream (IS), and two Perennial Streams (PS) for the widening and reconstruction of Battle Creek Road. The project would impact the 25-foot state mandated buffer of unnamed tributaries to Jester and Panther Creeks within the Upper Flint and Upper Ocmulgee watersheds. Disturbance activities would consist of drainage structure extension, acquisition of Right of Way, and reconstruction of streams. The proposed project runs from the intersection of Valley Hill Road and Upper Riverdale Road to the intersection of Mt. Zion Boulevard and Rex Road.
