Brumby Elementary School Replacement Project - Stormwater Pond Restoration
(Terrell Mill Road, Marietta, GA 30067)
Activity

This advisory is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of PermitApplication: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the construction of a new earthen dam adjacent to and downstream of the existing earthen dam on an unnamed tributary to the Chattahoochee River in Cobb County. This project will consist of dredging the existing stormwater pond, removing the existing dam and installing a new outlet control structure with a 48" RCP outlet pipe and an energy dissipator headwall and new concrete emergency spillway. The buffer vegetation will be restored to current existing conditions. Activities will result in permanent buffer impacts to 290 linear feet total (12,967 square feet total) along an unnamed tributary to the Chattahoochee River.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
